# INSTRUCTIONS FOR COMPLETING THE APPLICATION FORM

- Non-Qualified Institutional Investors are institutions that do not fall into any of the following categories; Banks, Fund Managers, Pension Fund Administrators, Insurance Companies, Investment/Unit Trusts, Multilateral and Bilateral Institutions, Private Equity Funds, Hedge Funds, Market Makers, Staff Schemes, Trustees/Custodians, and Stockbroking Firms.
- 2. Applications must be made only on the official form as prescribed by the FGN Roads Sukuk Company 1 PLC.
- 3. Applications must be for a minimum of ₩10,000.00 and thereafter, in multiples of ₩1,000.00. The value of the Sukuk applied for should be entered in the appropriate box.
- 4. The Application Form, when completed, should be lodged with one of the Issuing Houses/Receiving Banks/Placement Agents. Applications must be accompanied by full payment of the amount applied for, which must be paid to any of the Receiving Banks. Payment may be in any form acceptable to the Issuing Houses.
- 5. Payment narrations must include the individuals first name and BVN.
- 6. Applicants should note that no charges or fees would be paid by investors.
- 7. For the purpose of this application, residency classification refers to the country where the Applicant(s) permanently resides as at the time of filling the Application Form. Applicant(s) must indicate his/their residency classification in the appropriate box provided.
